# The Wallet Rosary™ Wholesale Account Agreement

Thank you for your support and for your interest in partnering to bring The Wallet Rosary™ to your customers and community!

In order to make this arrangement clear and beneficial for all parties, the following are basic terms and conditions that must be agreed to in order to access our wholesale partner program:

### 1. Placing a wholesale order

For first-time wholesale partners of The Wallet Rosary, the minimum order value is \$250, with a minimum of 10 units per SKU. Once established as a Wholesale Account, subsequent orders require a minimum of 10 units of any SKU ordered.

Wholesale orders are made via The Wallet Rosary's online store. Approved Wholesale Accounts will be provided a discount code to access wholesale resources on minimum wholesale orders.

### 2. Sales channels and retail price

The Wallet Rosary wholesale partner program is intended to supply brick-and-mortar retail outlets, recognizing that many retailers supplement with online sales channels.

Products or goods purchased from The Wallet Rosary may be included in a partner's online storefront, but may not be advertised or sold through electronic channels for less than the manufacturer's suggested retail price (MSRP), as listed on www.walletrosary.com.

#### 3. Wholesale Pricing

All prices are listed in US dollars. All Wholesale Accounts will receive 50% off the MSRP. Prices are subject to change without notice. The Wallet Rosary will cover the cost of shipping, postal insurance, and tracking for wholesale orders that meet the minimum order requirements.

# 4. Shipping and handling

The cost of domestic (USA) shipping, including tracking and insurance, is included in the cost of goods. Wholesale orders will be shipped within five (5) business days of the time of your order and will include tracking and shipping insurance. For larger orders and out-of-stock items, please allow 4-6 weeks for order fulfillment.

#### 5. Payments

The Wallet Rosary accepts debit and credit card (MasterCard, Visa, Discover, and American Express) payments for orders via the online wholesale portal. The Wallet Rosary does not offer a credit (net 30) program for Wholesale Accounts at this time.

#### 6. Returns

Return requests must be made in writing within five (5) days of delivery date, quoting invoice number and the reason for the return. No returns are acceptable without prior approval and delivery instructions. The cost of return shipping will be subtracted from the refund for the returned order.

## 7. Damages and defects

Please inspect all shipments immediately upon arrival. Please contact The Wallet Rosary within five (5) days of receipt of damaged or defective shipments. Returned merchandise will be replaced with new merchandise. Returned merchandise will not be accepted if it is held for more than 15 days after receipt.

### 8. International wholesale orders

We are open to considering wholesale partnerships internationally, however recognize the complexity that this introduces. Please reach out to The Wallet Rosary in advance of placing any international orders in order to ensure compliance with relevant laws and regulations.
